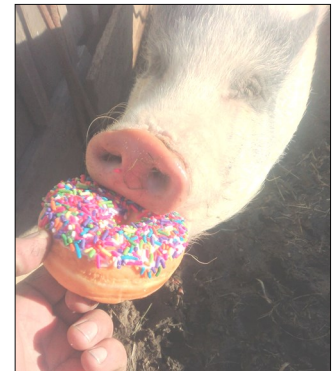
My Name is Doug Waxler. Starting this year, I have assumed the role of Chief of Hookstown Volunteer Fire Department. This is an organization of professional volunteers where I have proudly served for 19 years. I feel we at the Hookstown VFD owe a debt of gratitude for the community support we receive. I would also like to let you know, I have some growing concerns about the future of emergency services in our communities.

First, I would like to thank the residents of our communities, as well as the Township & Borough leadership. Community support is a primary source of our funding, and is critical to keeping our doors open and providing emergency response services. We quite literally could not do this without you. In addition to financial donations, community members have stepped in and assisted with fundraising and other various tasks. We appreciate and rely upon this help. Whatever your qualifications, everyone is encouraged to help as they can.

Second, I want to thank the department members themselves. These volunteers are a skilled, dedicated, and professional group that ensures that we respond quickly and mitigate all emergency situations in a safe and effective manner. Department members sacrifice their personal time, home life, and very often their sleep. **Our volunteer members also have demanding full time jobs like most of the folks in the community they serve.** This creates an ebb and flow in staffing available for emergency calls; particularly during the early morning through afternoon hours.

Unfortunately, even with the support of the community and hard work of our members, we are facing a crisis. Over the years I've served, there has been a steady decline in the number of volunteers available to help. In a recent early morning fire, we only had 3 available firefighters. This ultimately resulted in us having to call in additional help from far away departments.

This pattern of uncertain staffing comes up again and again. In 2020, medical calls requiring ambulances within Greene, Hookstown, Georgetown and Hanover Township averaged a 26.8 minute response time. During that 26 minutes, only Firefighter-EMTs were able to administer critical patient care. While we are not staffed around the clock, we do our absolute best to cover these scenarios and bridge the gap until the transporting ambulance arrives.

RE-OPENING

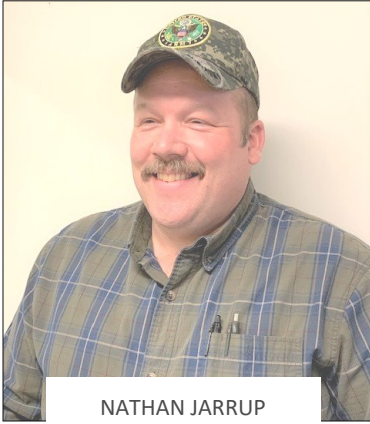

Back in the 80's Greene Township opened up a dumpster service to provide residents a place to dispose of unwanted items and keep roadways litter free. It's a service we have offered for more than 40 years free-of-charge to residents.

Over the years we've found creative ways to offset dumpster costs, like reducing operating days and separating out the metal to recycle it. Even so, scrap prices have continued to decline and landfill fees have increased 27% from \$10,986 in 2015 to \$13,967 in 2020.

Beginning March 20th there will be a small charge per use of the dumpster. Our goal today is the same as 40 years ago and we appreciate each and every one of you for aiding in this effort.

Small load—\$5.00 (car) • Medium load — \$10.00 (truck) • Large load — \$15.00 (trailer)

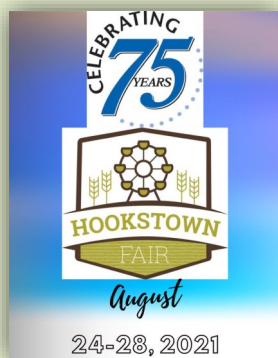

EAGLE SCOUT PROJECTS IN THE TOWNSHIP

Eagle Scout Trevor Infantozzi has completed his project of restoring the Covered Bridge on the Township farm. His work included stabilizing one of the telephone poles under the bridge, replacing the roof and missing boards, clearing up brush and trimming trees around the bridge. Trevor started this project on July 10, 2020 and finished on February 20, 2021. Trevor, fellow Scouts, parents & volunteers put in a combined 1162.75 manhours to complete the project.

Logan Blake is also performing community service projects for his Eagle Scout badge. He has chosen to restore the North Mile Trail by replacing a 24 x 30 plastic culvert pipe at a crossover on the trail, located about 50 yards after crossing the covered bridge. He will also fill in small sink holes at the trail switchback and remove fallen trees and debris in the drainage area and stabilize the crossing switchback with barn stone wing walls.

We anticipate that the North Mile Trail will provide ongoing Eagle Scout project opportunities in the future.

The township would like to thank Trevor and Logan for taking on these projects and helping make our parks and recreational areas more useful and beautiful.

GPPT, LLC SOLAR FARM - LAND DEVELOPMENT UPDATE



The Planning Commission recommended the GPPT, LLC Land Development Plan for approval to the Board of Supervisors on March 16, 2020, just as Pennsylvania began a COVID-19 pandemic lockdown. The PADEP issued a Storm Water Permit for the project in the fall of 2020.

The project site consists of 210 acre located within a 448 acre parcel and will be accessed from Hill and Cain Roads.

In February of 2021, Duquesne Light Co. began contacting affected landowners with information regarding an upgrade from single phase to three phase power on Cain Road. Duquesne Light has completed all engineering work associated with the required upgrades and anticipates issuing contracts to construction firms in March 2021, with site work to begin shortly thereafter.

Tree clearing and grubbing activities are expected to begin in June of 2021. Construction is currently targeted to begin in July 2021 and continue through the first quarter of 2022. GPPT, LLC reports that construction has been impacted and delayed by equipment shortages and long lead times for some equipment.

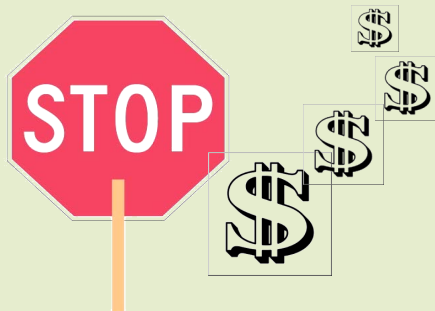


MAGGIE'S PIE CRUST

- 2 cups flour - brand name preferred
- 2/3 cup shortening (Crisco or lard)
- 1 tsp salt
- 3 tbsps sugar
- water

Mix all together using your hands until it resembles crumbly peas. The temperature of your hands will soften the shortening. Add water to form ball. How much water will depend on the moisture content of your flour.

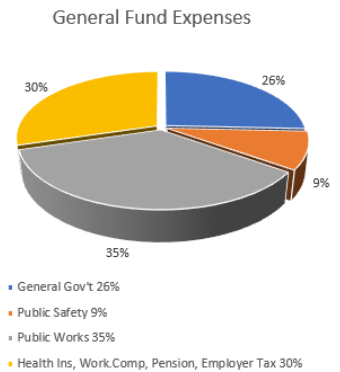
THE COST OF 1 STOP SIGN

Stolen and damaged stop signs in the township is a regular occurrence. Since January, the township road crew has replaced the same stop sign 4 times, not to mention various road name signs last year. Each new sign is an expense to the township and, ultimately, paid for by taxpayers. If you see damage being done to signs please call the police and report it to the township.

BUCKETS OF MONEY

The General Fund Budget for 2021 is based on a Real Estate Tax rate of 9 mills, 1 mil of which is designated to the Emergency Services Board. The remaining 8 mills is used for such things as wages and benefits, recreation, public safety, planning activities, legal and engineering work, tax collection services, insurance, dumpster service, buildings and grounds.

In the past few years, the cost of 'doing business' has continued to climb, with the revenue streams continuing to be fairly consistent from year to year. With this in mind, the Greene Township Board of Supervisors and it's staff have remained steady in their determination to keep a tight budget on track without raising taxes for a 5th consecutive year.



The Liquid Fuels Fund is for expenses related to road materials and maintenance. Revenue for Liquid Fuels comes annually from PennDOT, derived from state license fees and gas taxes. Since the actual gallons of gasoline purchased by Pennsylvania residents in 2020 was significantly lower than prior years, the amount of money received by PA municipalities was also much less. The 2021 Liquid Fuels allocation of \$155,696.40 was \$15,097.17 LESS (approximately 9%) than that received in 2020. The reduced allocation, along with increasing costs for road materials and fuel, will make it much more difficult to maintain township roads in the coming year. Turnback funding from PennDOT, earmarked specifically for maintenance of Georgetown Road and McCleary Road, remains the same at \$24,560.00 annually.

Liquid fuels funds will be used to perform routine maintenance, such as cross drain replacement and/or seal coat & tar and chip, on several roads this season.

ANTISKID NEEDS

For more than 40 years Greene Township has received a free supply of bottom ash which was used on township roads as anti-skid. The closure of the First Energy fossil fuel plant means, going forward, we will not only have to purchase anti-skid material, but we must also construct a building in which to house it. Meetings with the township engineer to discuss funding and available grants for this project have been productive and we hope to move forward in the coming year.



ROUTE 30 REALIGNMENT

As many of you may know, the Route 30 realignment project was originally intended to start in the Spring of 2020. However, COVID affected nearly everything and the Route 30 project was no exception. Crews were not able to start until November of 2020 which pushed the project well past its original planned completion dates.

The Red Dog Road closure and detour is scheduled to start August of 2021 and last until January 2022. The mainline Route 30 closure is scheduled to start March of 2022 and last until August of 2022. There is a tremendous amount of utility involvement which could potentially cause delays. Absent delays, the project could be completed in October of 2022.
