<p>Soil Probes (Per Visit) – Property Lines must be marked/known. Actual Costs Incurred will be Billed by Hourly Rate <u>(Skip to Step 4 if lot is planned)</u></p> <p>*\$720.00 Deposit Required Prior to Scheduled Test Date for Soil Probes and/or Percolation Test. Additional Deposits may be necessary Depending on Complexity of the Project. Balance Refunded Upon Completion*</p>	\$720.00 + \$90.00/Hr.
<p>Percolation Test (Per Visit) – Site must be prepped and ready for test. Actual Costs Incurred will be Billed by Hourly Rate. Percolation Test may not always be required if alternate system is cited by Soil Scientist. <u>(Skip to Step 4 if lot is planned)</u></p> <p>*\$720.00 Deposit Required Prior to Scheduled Test Date for Soil Probes and/or Percolation Test. Additional Deposits may be necessary Depending on Complexity of the Project. Balance Refunded Upon Completion*</p>	Previous Deposit + \$90.00/Hr.

<p>Planning Module Review</p> <p>*Only required for new subdivisions and unplanned lots after May 15, 1972*</p>	\$90.00/Hr.

<p>Design Review/Permit Issuance (Due with Submission)</p>	\$180.00
<p>Additional Submissions or Reviews</p>	\$90.00/Hr.
Step 5	
<p>Inspection [Per Visit with a Minimum 2 Visits] (Assume 2 Hours Port to Port)</p>	\$90.00/Hr.
Step 6	
<p>Send Completed Permit Application Package to Property Owner (Assume 1 Hour)</p>	\$90.00

10 Acre Exemptions	\$250.00
The Applicant is permitted to pay only \$25.00, since that is the maximum fee allowed by the Sewage Code. The remaining cost will be incurred by the municipality.	
Reissue Expired Permit (Using Prior Testing and Design)	\$500.00
Violation Investigations	\$90.00/Hr.
Initial Applicant Inquiries (Exceeding basic information)	\$90.00/Hr.
Activity Record & Reimbursement Forms	\$90.00/Hr.
