

The Greene Township Board of Supervisors may, at any time, revoke and annul this permit for non-performance of or non-compliance with any of the conditions, restrictions and regulations hereof.

No work shall begin without the approval of the township Road Foreman or Road Master.





§ 153.218 DRIVEWAY REGULATIONS.

- (A) Driveways shall be designed in such a manner that would prevent the driveway material and associated stormwater from entering onto a public road.
- (B) Residential driveways must be a minimum of five feet from property lines, subject to the right of adjoining property owners to enter joint driveway agreements, unless otherwise specified by the provisions of this chapter.
- (C) Driveways for commercial and industrial uses shall have a minimum width of 20 feet unless specified otherwise by applicable regulations and must be a minimum of ten feet from property lines.
- (D) Access drives to and from off-street parking, loading and vehicle service areas along public rights-ofway shall consist of well-defined entrances and exits.

The first 25-foot length of the driveway for which you applied must be covered with gravel, slag or comparable material. Going forward, sight visibility must be maintained through vegetation control by the property owner and cannot be obstructed by the erection of fences or other objects.

The Greene Township Board of Supervisors may, at any time, revoke and annul this permit for non-performance of or non-compliance with any of the conditions, restrictions and regulations hereof.

All questions regarding the construction of the driveway should be directed to the township Road Master or Road Foreman

Once your driveway is complete and approved by township personnel, the bond portion of your payment will be released and mailed to you.
