PARK DEVELOPMENT

Greene Township was awarded a \$55,000 grant from the Department of Conservation and Natural Resources to build a pavilion overlooking Millcreek Community Park near the comfort stations (aka restrooms) near the old garage.

The Township will make both cash and in-kind contributions toward this project. The area of construction will be prepped and graded by township crew and raising of the pavilion will begin this fall by Recreation Resource USA.

Those wishing to rent the 24'x36' pavilion will enjoy the use of running water and covered seating for approximately 50 guests. Future upgrades, including electricity, are also planned.

The pavilion, parking and restrooms all reflect ADA accessibility and guests are encouraged to visit the park and enjoy all the amenities it has to offer.

USING AMERICAN RESCUE PLAN FUNDS

In years past, Greene Township has been fortunate to receive bottom ash from First Energy to treat snow and ice on our local roads. This material could withstand the elements and did not have to be housed in a building. After the production of this material was discontinued, the township purchased similar material from another local plant for a small fee.

In March 2022, the township applied for a Local Share Account Statewide Grant to erect an anti-skid storage building to house future purchases of anti-skid material. We recently learned that this application was not approved. However, the anti-skid shed will still be built this fall using American Rescue Plan funds which were received by all PA municipalities who applied for them in 2020. The amount awarded to Greene Township was \$246,286.66.

FIRE PROTECTION WATER SUPPLY

In 2005, Greene Township entered into an agreement allowing spring water to be collected on township property and transferred via pipe to a fire hydrant on the Hookstown Grange's property.

This water easement was designed to provide non-potable water for emergency use by the fire department and for occasional grange events held on the fairgrounds.

We are fortunate to have this water source in our community and wish to provide water to those in need on an occasional basis. Anyone other than the fire department who wishes to get water shall contact the Greene Township office so that a count of gallons available is accurate should the fire department have an emergency need.

HOME-BASED BUSINESSES EXPLAINED • Know the difference!

A "no-impact home-based business," is a permitted use-by-right in all Zoning Districts that allow for a residential dwelling (A1, R1, R2). Generally this business type does not have any impact on neighbors.

- 1. Are compatible with the existing residential use of the property.
- 2. Have no employees other than family members residing at the property.
- 3. Have no outside appearance of a business, including: storage of goods/materials, parking, signs, or lighting in excess of a normal residential use.
- 4. May not create a nuisance (noise, vibration, glare, etc.) that is detectable to neighboring properties. Any verified complaints of this nature may result in the approved business license being revoked by the Zoning Office.
- 5. May not increase vehicular or pedestrian traffic.
- 6. Must be conducted within the existing dwelling and not occupy more than 25% of the habitable floor area.



Accountant Tailor/dressmaking Home baked goods Artistry/Ceramics Barber/Beauty shop Tutoring Music teacher Real estate agent Computer Repair Or a business where you build something in your home and sell elsewhere. **A "home occupation,"** is only permitted in the A-1 (Agricultural) District. Since they may have a small impact on the community, public input is sought and a Zoning Hearing is held for Special Exception approval.

- Tend to be slightly less compatible with a traditional residential neighborhood due to uses permitted, which is why additional approval must be obtained. However, they are not allowed to negatively impact the surrounding area or the property values of neighboring lots.
- 2. Not permitted to employ more than two (2) persons living on the premises.
- 3. Signage must be reviewed and approved in accordance with the Township Ordinances. These signs may not exceed four (4) square feet in area.
- 4. Not permitted to publicly display good/materials on the premises.
- 5. The use shall comply with the performance standards in the Township Ordinances, which detail requirements for noise, air pollution, etc. Disturbance that is not in violation of these performance standards may be permitted.
- 6. Vehicle or pedestrian traffic may not be *significantly* increased because of this business.
- 7. Must be conducted within the existing residential dwelling or related accessory structures. If conducted in the existing residential dwelling, no more than 25% of the gross floor area may be used.

Both types of businesses require annual approval of a permit based on an inspection by the <u>Zoning Office</u>. The application can be found on the Township's website, <u>greenetownship.net</u>, along with the <u>Township Zoning Ordinance</u>.

ATTENTION LANDLORDS



If you rent a house, mobile home or one of your mobile home sites, you are subject to Chapter 124 of the Greene Township Code, which requires that you annually (before October 31) submit a landlord occupancy form for each dwelling or lot that you rent out. It also requires that the township administrative office be notified within 10 days of a change in tenants. More information can be found here:


